### KITE FLYERS CODE

1. Never fly near transmission towers, antennae or power lines (if a kite becomes entangled in a power line LEAVE IT THERE and contact the Hydro Electric Commission's Emergency Service, as soon as possible).
2. Never fly a kite during an approaching storm or in the rain a wet line and some kite spars will conduct electricity. Also, never fly using wire for flying line.
3. Always observe air safety regulations - 90 metre height limit, and not within a 4 km radius of an airport.
4. Kites should always be used in open areas - away from people, buildings, trees, cars, roads, power lines and animals.
5. Never swoop down on people or "buzz" them with your kite.
6. Always respect other kite flyers, their kites and their flying space.
7. Do not use "Kevlar" lines (it is hard and abrasive and cuts through most other lines and also human tissue).
8. Always clean up any rubbish you may have created while flying.
9. Always follow the four "C's" of kite flying:

**CAUTION**

**COURTESY**

**COMMON SENSE**

and **CONTROL.**
